

Darksichord License Agreement

This End-User License Agreement (“EULA”) is a legal agreement between you and Elektronik Sound Lab

This EULA agreement governs your acquisition and use of our Darksichord software (“Software”) directly from Elektronik Sound Lab or indirectly through a Elektronik Sound Lab authorized reseller or distributor (a “Reseller”).

If you register for a free trial of the Darksichord software, this EULA agreement will also govern that trial. If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity and its affiliates to these terms and conditions.
